January is a time for renewed energy and determination, and we can start the year with some encouraging international progress. **COP15's Global Biodiversity Framework** – particularly its commitment to reduce harmful government subsidies by USD 500 billion annually by 2030 – will help redress unsustainable food production. Clearly, global momentum is building for the creation of sustainable, resilient and equitable food systems. What remains is to transform this momentum into timely, effective and lasting action.

2023 also brings change for the JRT community. Global Forum for Food and Agriculture 2023

JRT was pleased to see that this year's <u>Global Forum for Food and Agriculture</u>, held on 18–21 January, was centred around the theme of 'food systems transformation.' It was heartening to see the Forum commit to better aligning its various policy instruments – including multilateral cooperation and bilateral agreements – to achieve the policy coherence needed to bring about transformative change. A particular highlight of the four-day event was a high-level panel, Redirecting Agricultural Policies and Support to Address Climate Change. Looking back at the Policy Dialogue to Accelerate Transition to Sustainable Agriculture, launched by the UK COP26 Presidency and the World Bank, the panel brought together policymakers to discuss the challenges and opportunities for collaboration in building climate-resilient, low-carbon and sustainable agrifood systems through policy action.

COP27: Advice from farmers

JRT's latest video, COP27: Advice from farmers, showcases the insights and expertise of food producers working on the frontlines of the climate crisis. Their knowledge is essential to build resilient, sustainable and equitable agrifood systems, and they must be included in decision-making. As Daphne Muchai, Executive Director of the Women Farmers

Association of Kenya, states in the video: "Make decisions with the farmer, not for the farmer."

Investing in a just rural transition

On top of supporting Food Day at COP15 in Montreal in December, we co-published the <u>final investment analysis brief</u> from an investigation into women-owned agri-SMEs in Indonesia. JRT Investment Partnerships and the <u>World Business Council for Sustainable</u>



An Introductory Guide for Net Zero Target Setting for Farm-Based Agricultural Emissions



Aligning regenerative agricultural practices with outcomes to deliver for people, nature and climate


This new report by The Food and Land Use
