JRT's Evolving Governance and Expressions of Interest to be part of a JRT Advisory Group

The JRT's governance framework should reflect and support our 2030 vision—to bring diverse stakeholders together to transform the way in which we produce and consume food, and use our land and natural resources to provide nutritious food for a growing global population while protecting the vital natural systems which sustain life. The JRT aims to mobilise powerful coalitions of actors and support collective action that ensures people—particularly small-holder farmers, indigenous and local rural communities—are at the heart of efforts to address climate change and the degradation of nature, promoting sustainable and equitable development.

The JRT's "community of purpose" comprises governments (Global North and South), farmer and producer organisations, food companies, international knowledge and financial institutions, non-governmental organisations, foundations, associations, coalitions and other actors who commit to contribute to achieving the JRT's vision.

The Advisory Group will be comprised of entities representing the diverse stakeholder groups listed above. The Advisory Group will provide high-level strategic guidance and input to the JRT Initiative, identify opportunities to scale impact and embed JRT principles and objectives in relevant global and national processes and initiatives. We propose a senior level meeting (Ministerial/Head of Organisation) twice per year, with working-level meetings held on a monthly basis. JRT Dialogue on Land Rights and Land Tenure

How do we define Just in the Just Rural Transition? Indigenous and local communities customarily own and manage 50% of the world's land but only hold legal titles to 10%. Securing land tenure and community land rights could help unlock racial justice, gender equity, and food sovereignty.

On 9 and 11 June, the JRT Secretariat held two dialogue sessions in partnership with the <u>Rights and Resources Initiative</u> to engage the broad and diverse JRT network and scope potential priority areas for collaboration on this critical and timely topic.

Participants explored how the JRT can promote policy reform and investment partnerships to unlock opportunities to advance justice in all dimensions of our work, including secure land tenure for marginalised and vulnerable communities. It is vital that those whose land rights and livelihoods are impacted by agri-food policy reform—indigenous peoples, afrodescendant communities, farmers, women and marginalized groups—are part of any dialogue process at the local and national levels. The JRT can also promote awareness and understanding on this topic at the global level.

The PAC's COVID Dialogue Series

The JRT's Policy Action Coalition (PAC) was created prior to the onset of the COVID-19 pandemic. The ensuing health and economic crisis resulted in new realizations, new challenges and new priorities for all stakeholders involved in food system transformation. To help make sense of what this means for how the JRT can support policy reform in this challenging and evolving context, the PAC convened three virtual dialogues.

The dialogues explored the emerging impacts of COVID-19 on livelihoods and value chains, climate change and the environment, and nutrition, focusing on medium to long term needs and responses. Themes included the fragile, risk-prone nature of value chains, the critical interdependencies of human, environmental, and animal health (i.e., One Health), and the opportunity for country governments to 'build back better' with policies that address both medium term concerns (food insecurity, jobs, and value chains), and longer-term ones (environmental degradation, climate change, biodiversity loss and nutrition). The PAC has distilled these learnings within its report, COVID-19: Re-emphasizing and Reshaping Priorities for the Policy Action Coalition. It looks forward to further integrating these take-aways into future engagements with country partners.

IPN Workstream Updates

The IPN team is in the midst of a learning and vision setting phase. The team is currently conducting stakeholder interviews with key investors, agri-businesses, and civil society organizations in order to shape the vision and focus of the program, which will be followed later in August by several consultation sessions to further refine our theory of change, hone our value statement, and continue building support for the initiative. Community News



25+ Leaders from the Global Commission on Adaptation call on decision-makers to incorporate climate resilience into COVID19 recovery packages in 7 key areas, in its recent statement.

The World Economic Forum released the second report of its New Nature Economic Reports series: The Future of Nature and Business. The report sets out a blueprint for business to achieve 15 transitions and transform the world's three most nature-destructive socio-economic systems —generating up to US\$10.1 trillion in annual business value by 2030, creating 395 million jobs.

According to its most recent <u>State of Food Security and Nutrition in the World (SOFI)</u> report, the FAO suggests we are not on track for zero hunger in 2030. The report addresses food affordability, unhealthy diets, and the toll of the pandemic.

The Food and Land Use Coalition's latest <u>discussion paper</u> presents a framework for understanding food systems resilience and policy responses in the face of COVID-19, featured on its new <u>COVID-19 corner</u>.
